RE: Road Improvements

Scope of Work: Import Base, (Millings), Grade, Pave at 1.5 Inches.

Area/Locations: 12,136 Square Yards, (Includes Widening of Shoulders with Millings).

- Scarify as necessary the existing shell base to allow for integration of the asphalt millings for additional base strength.
- Remove the existing vegetation, (sod) along the outer edge of the road footprint to allow for a new shoulder, (where applicable), and remove from the site. Import and install a new asphalt milling shoulder, not to exceed 1 foot wide, to a depth of approximately 5 inches.
- Import and install Recycled Asphalt Millings, to a finished compacted thickness of 3 inches. Grade to attain proper cross-slope, (minimum 1.5%), compact to attain proper density for paving.
- Apply Special MS tack/prime at a rate of .10 gallons per square yard.
- Import and install Type S3 surface course asphalt to a finished compacted thickness of 1.5 inches, (to a finished compacted thickness of 3 inches in Cul-De-Sac's to withstand Truck Traffic, and along each driveway a 5-foot "wing" will be added to ensure the edge of the new pavement will be protected from erosion).

TOTAL PROJECT COST: \$160,000.00, (Note: Price based on a December 11th or 18th Start Date. Price subject to change, (Increase), if to start in Spring 2018. Price also includes "Runway" Shoulder Touch Ups.

Soon Come, Inc. to provide a 3 Year Warranty on all Workmanship and Materials.

New Pavement Will Scuff (Power Steering Marks), for a period of 12 months from the time of completion. This is typical, and will blend away in time.

Soon Come, Inc. is not responsible for Private Utilities that are not located by the Owner.

Soon Come, Inc. reserves the right to withdraw this proposal within 30 days if not accepted.

Exclusions:

- Sod, Seed, or Topsoil for Landscaping.
- Utility or Irrigation Sleeves.
- Repair of broken Irrigation Heads, Irrigation Lines, Utility Lines (Private) that are not located by the owner within the foot print of the existing shell road.
- Silt Fence, or any other additional item that Lee County/Sanibel may require prior to construction.
- Underground Utilities Construction is not part of this Contract.
